What will you do?

Your tasks will include:

- International and interdisciplinary collaboration and advisory on legal issues concerning intellectual property, data privacy, corporate governance, compliance, and risk management.

- Providing internal knowledge sharing on various legal issues, including end-user license agreements (EULAs).
